PURPOSES

LEARNING OBJECTIVES

1. To know the different expressions of architecture during the named period of the “Modern Movement”.
 2. To comprehend the modern architectures as particular situations regarding the buildings ensemble that constitutes the built space.
 3. To evidence the correspondence between architecture, the urban discipline and the politic, social and cultural framework that gave them origin, as well as their bilateral relations of influence.
 4. To verify the historic significance of the presence, during the modernization period of Latin America, of the diverse architectonic trends in the first half of the 20th century.
 5. To understand the dialectic relationship between those trends, its Latin American manifestations and the rest of the architectural and urban regional landscape.
 6. To know the urbanization processes in Latin American cities, with its narrow relation with architecture and with the physical transformation of the environment, derive from the modernisation ideal.
 7. To initiate the student in the reflection regarding the valorisation of the non-monumental buildings that form part of the national architectural and urban heritage.

TOPIC 1. The difficult emergence of modern architecture in Germany.

H. P. Berlage and the Amsterdam School. Urbanism of the first post-war in Rotterdam. The Neo-Plasticism. G. Rietveld, W. M. Dudok. The urbanism of Vienna, between the Sezsesion and the “hofes”. The “English neo-picturesque” and the legislation of housing in the first post-war.

TOPIC 4. Tradition, modernity and futurism in Italy.

Academic tradition in Italy. Liberty. The work of G. Michelucci, G. Terragni y M. Piacentini. The regulatory plans. The *Instituto per le Case Popolari*. The architectonic experience of the University City of Rome. The Universal Exposition of 1942.

TOPIC 5. Academic tradition and modern tradition in France.

From Art Nouveau to Art Deco. Tony Garnier and the urbanism of the industrial city. Choisy and Guadet. A. Perret. París, in the twenties: Academy and Modernity. The Paris Expositions of 1925 and 1937. The work of R. Mallet-Stevens and A. Lurcat.

TOPIC 6. Modernism and modernity in Spain

From the Calatan Modernism to the Barcelona Exposition of 1929. The heritage of Gaudí. The activity of the GATEPAC: J. Ll. Sert. The Neo-monumentalism in Madrid. Architecture of the Spanish regionalisms: the Iberoamerican Exposition of Seville of 1929.

TOPIC 7. Traditions, vanguards and rationalisms in the Soviet Union

Vanguards and disillusionment. Urbanisation and de-urbanisation. European visitors: Le Corbusier, H. Meyer, E. May, etc. M. Ginzburg: the Building Committee and the social condensers. The contest for the Palace of Soviets. The neo-monumentalism.



UNIT 2. *Architecture, City and Territory in Latin America*

TOPIC 1. Territorial space and urbanism of Latin America in the first half of the 20th century.

The colonial heritage, the inheritance of the nineteenth century and the urban expansion. The period of the Regulatory Plans. Influences of the European urbanism: the CIAM and the visitors.

TOPIC 2. Eclecticism before and after: 1900-1950

The national and the international in the architecture of Latin America and the Caribbean. The protagonists and its works: Julio Vilamajó, Lucio Costa, Juan Villagrán, Oscar Niemeyer, Juan O'Gorman, etc. The Argentine case. The Visitors.

TOPIC 3. The architecture of the underdevelopment: Creation or Imitation

The adoption of the new trends: Chile, Colombia, Peru, Cuba. The architecture under the neo-colonialism: Puerto Rico and Panama. Traditional-modern architecture in Peru and Chile.

UNIT 3. *Architecture, city and territory in Venezuela*

TOPIC 1. Architecture, Public works, urbanism and petroleum.

Historical process of the Venezuelan architecture. Territorial occupation process, construction of infrastructure and urbanisation. Stages of the Minister of Public Works. Architectural typologies in the cities. Petroleum, urbanisation and architecture.

TOPIC 2. Architecture and urban grow of Caracas city.

Expansion, extension and densification of the city in the first half of the 20th century. The state action: The Worker's Bank. The entrepreneurial action. The Rotival Plan. The re-urbanisation of El Silencio. The university city, the worker's city, the holiday city.

TOPIC 3. Expressions of the modernity in architecture of Caracas.

Dialectic of the traditional and the modern. Continuity and innovation. The search of the modern architecture, but national. The Neo-hispanicism. From Alejandro Chataing to Carlos Raul Villanueva. Other protagonist: M. Mujica. C. Domínguez, R. Bergamín, L. Malasussea, G. Wallis, R. Seijas Cook, L. E. Chataing, etc. The fifties: "Modern Caracas".

UNIT 4. *City and architecture in the United States of America*

TOPIC 1. Chicago, New York and the skyscrapers: From Sullivan to the Chrysler Building. The work of F. Ll. Wright, R. Neutra in the United States of America.

TOPIC 2. Mission style and Art Deco: From San Diego exposition of 1915 to Miami. The dwelling: legislation, experimentation and construction.



INSTRUCTIONAL STRATEGIES

The course is being developed over a period of fourteen weeks. Every week a didactic session of two continuous hours is held. In the first part of it, the professor exposes the topic, under the conditions of the previous reading of one or various specific texts regarding the topic. The students will attend these sessions or classes provided with previous knowledge of the subject, obtained from the reading of the textbooks.

Each class will begin with the first phase of levelling of knowledge, through the participation of the students and the professor. A second phase will be in charge of the professor, who will dictate a master class regarding the topic, supported by audio-visual resources and with variable time according to the subject. If possible a lecturer will accompany the class, who will contribute an integral vision of a specific topic.

EVALUATION

The course of History of Architecture IV will be evaluated as follows:

One sectorial exam, written, once ended the four-month period, with a value equivalent to 35% of the final grade.

One team task (3 members) regarding one of the topical contents of Unit 3. To be assigned by the professor, with a value of 40% of the final grade.

One individual monographic assignment about one of the topical contents of the rest of the program, to be chosen by the student, with a value of 20% of the final grade.

5% of attendance. The attendance is mandatory and is subjected to the PPI rules. The non-attendance of more than 4 sessions, will be reason for the loss of the course.
